2 Secretary and President's Reports on the Association's Activities, September 2004-  
November 2004

The Secretary of the Association, Joel Butler, had prepared a written report which was circulated to members prior to the meeting. Joel thanked the other members of the National Committee for their support and assistance, and highlighted ALLA's success in being chosen as host for the 2009 World Congress of the International Society for Labour and Social Security Law (ISLSS), which will be held in Sydney.

The Secretary's Report was received by the meeting.

Ron McCallum delivered an oral report to the meeting. Professor McCallum thanked the National Committee for their efforts throughout the year. He noted that ALLA was in a strong position, with financial accounts prepared, and a healthy list of members.

Ron McCallum reported that the 2004 National Conference had been very successful, with innovative speakers on important topics. Professor McCallum thanked Justice Gray for being the guest speaker for the Conference Dinner.

Professor McCallum also thanked the sub-committee which organised ALLA's bid for the 2009 World Congress, and reported that the Secretary of the ISLSS had informed him that he had

never seen such a well-planned bid. A new sub-committee would now be formed to organise the conference, including venues and translations.

Professor McCallum also thanked all those who had attended the 2005 Asian Regional Conference of the ISLLSS in Taiwan.

### 3 Receipt and consideration of financial statements

Joellen Riley, the Association's Treasurer, tabled the accounts for the financial years 2004-2005, as required by s30A of the *Association's Incorporations Act 1981 (Vic)*. The Treasurer tabled the written report, a copy of which is attached to these minutes, and discussed the main features of these accounts. It was noted that the accounts would be audited in the near future to ensure compliance with section 30B of the *Association's Incorporations Act 1981 (Vic)*.

#### 5 Other business

Ron McCallum indicated that ALLA was planning to hold its annual conference in 2006. There had been some discussion about Queensland hosting the conference, and he would leave it up to the Queensland Chapter of ALLA to make a decision about the feasibility of this as soon as possible.

Ron McCallum suggested that the National Conference should be held after September 2006, as the 2006 World Congress of the ISLSSL was being held in Paris in early September, although it was important the conference be held in a non-teaching period.

John Howe and Anna Chapman noted that labour law teachers around Australia wished to hold a 'Labour Law Teachers' Workshop' to coincide with the National Conference.

Professor Marilyn Pittard, on behalf of the convenors of the Victorian chapter of ALLA, extended an invitation to ALLA members to attend Victorian Chapter's end of year function on 7 December at the Monash Law Chambers, with special guests Giudice J, President of the AIRC, and Prof George Williams.

Ron McCallum again thanked Jane Harvey and Blake Dawson Waldron for hosting the meeting.
