

Presenter Biographies



Rehan Abeyratne is an Associate Professor of Law at the Jindal Global Law School, where he has taught since 2011. He also serves as Assistant Dean (Research) and as Executive Director of the Centre for Public Interest Law. He has a B.A. in Political Science from Brown University and a J.D. from Harvard Law School. His research and teaching interests include comparative constitutional law, international criminal law, national security law, and legal theory. His published works include a recent article on 'Rethinking Judicial Independence in India and Sri Lanka' (2015) 10 *Asian Journal of Comparative Law* 99. His other publications have appeared or are forthcoming in the *Nebraska Law Review*, *Yale Journal of International Law*, *Brooklyn Journal of International Law* and *George Washington International Law Review* and in edited volumes published by Hart, Cambridge University Press and Oxford University Press. He is currently working on a monograph entitled *Socioeconomic Rights in India*, which is forthcoming with Oxford University Press.



Farrah Ahmed joined Melbourne Law School in July 2012. Before this, she was a Lecturer in Law at the Queen's College, University of Oxford. Her educational history includes an LLB from the University of Delhi, and a Bachelor of Civil Law, an MPhil in law and a DPhil in law from the University of Oxford. Farrah's research spans public law, legal theory and family law. Her recent work on constitutional statutes, religious freedom, the doctrine of legitimate expectations, the duty to give reasons, social rights adjudication and religious tribunals has been published in the *Cambridge Law Journal*, the *Modern Law Review*, the *Oxford Journal of Legal Studies*, *Public Law*, and *Child and Family Law Quarterly*. Her book *Religious Freedom under the Personal Law System* was published by Oxford University Press in 2016. Farrah is currently a Chief Investigator on an Australian Research Council Discovery grant studying religious dispute resolution processes, and is working on projects on public interest standing, secularism, constitutional conventions, constitutional principles and arbitrariness in public law. Farrah has taught legal theory, legal methods, constitutional law and administrative law. She has offered electives on human rights, legal responses to multiculturalism and religion, and legal practice in Asia. Farrah is a founding editor of the *Indian Law Review* and the *Admin Law Blog*. She also serves as Associate Director (India) of the Asian Law Centre, Melbourne Law School.



Erika Arban is an ARC Laureate Postdoctoral Fellow in Comparative Constitutional Law. Her research focuses on comparative federalism, comparative constitutional law and legal research methodology. Before joining the project, she lectured in Comparative Federalism at the University of Antwerp (Belgium) and in Public Law at the University of Ottawa (Canada). Erika received her PhD at the University of Ottawa (Canada), where her doctoral thesis *Italian Regionalism and the Federal Challenge* was awarded the Governor General Gold Medal for the best thesis in the Humanities. Eszter Bodnár is a Kathleen Fitzpatrick Visiting Fellow with the ARC Laureate Project in Comparative Constitutional Law. Her research interest is in comparative constitutional law, international human rights, and European constitutional law. She has been an assistant professor at the Faculty of Law of University Eötvös Loránd (ELTE) in Budapest, Hungary since 2013. She is also a faculty member in the Master of Electoral Policy and Administration program of Scuola Sant’Anna, Pisa. In the last years, she has been teaching and researching in Germany, France, the United States, the Czech Republic, Portugal, Italy, and Canada. She graduated as a lawyer and worked at the Department of Constitutional Law in the Hungarian Ministry of Justice, and in the Hungarian National Election Office. She obtained her PhD degree in constitutional law at ELTE in 2013 with her thesis on the fundamental right attributes and restrictions of the right to vote that was published in Hungarian (HVG-Orac, 2014). Currently she is working on a comparative constitutional law project on open justice, seeking the answer on how the courts should answer the challenges of the 21st century in a constitutional way.



Edin Hodžić, PhD, Director and Head of the Public Law Program at Center for Social Research Analitika. He is also a member of the Centre for Human Rights and Legal Pluralism, McGill University, as an Associate Fellow. Edin holds a doctoral degree in International and Comparative Law from the Institute of Comparative Law, Faculty of Law, McGill University, Montreal, as an O’Brien Fellow. Edin has obtained his Master's Degree in International Human Rights Law, with Distinction, from the University of Oxford, for which he received support through a joint scholarship scheme. She obtained her Bachelor of Arts in Jurisprudence (First Class Honours) and Bachelor of Civil Law (Distinction) from the University of Oxford. Swati previously practised law at Allen & Overy, specialising in international commercial arbitration and is a Solicitor of the Hong Kong SAR and England & Wales and a Member of the Chartered Institute of Arbitrators. Swati is currently working on papers looking at the need for more comparison in the field of administrative law; and the role of the executive (as opposed to courts and parliament) in generating constitutional norms and meaning.

Russell Miller is the J.B. Stombock Professor of Law at the Washington & Lee University School of Law where his research and teaching focuses on public law subjects, especially from a comparative perspective. He has published extensively on German law and legal culture, including a forthcoming text book introducing German law from Cambridge University Press, the edited volume *Privacy and Power: A Transatlantic Dialogue in the Shadow of the NSA-Affair* (Cambridge University Press 2017), and, with Donald Kommers, the third edition of the leading English-language treatise on German constitutional law *The Constitutional Jurisprudence of the Federal Republic of Germany* (Duke University Press 2012). He is the founder and long-serving Co-Editor-in-Chief of the *German Law Journal*. He has been a Fulbright Scholar and he has a cross-appointment with the Washington & Lee College of Arts and Sciences.



Jaclyn L. Neo is a Kathleen Fitzpatrick Visiting Fellow with the ARC Laureate Project in Comparative Constitutional Law. She specializes in comparative constitutional law in Southeast Asia, comparative constitutional law and religion, as well as human rights. Currently an Assistant Professor at the Faculty of Law of the National University of Singapore (NUS), Jaclyn was a recipient of two graduate scholarships from NUS under which she completed her Masters of Law (LL.M.) and Doctor of the Science of Law (J.S.D.) at Yale Law School. Her articles have been published in the *International Journal of Constitutional Law (I-CON)*, *Oxford Journal of Law and Religion*, *Human Rights Quarterly*, and the *Singapore Journal of Legal Studies*. She is also the sole editor of a recently published volume on *Constitutional Interpretation in Singapore: Theory and Practice* (Routledge, 2017). Iddo Porat is an Associate Professor of Law at the College of Law and Business, Israel. He specialises in constitutional law, comparative constitutional law and legal theory. Cheryl Saunders has specialist interests in Australian and comparative public law, including comparative constitutional law and method, multi-level government and constitutional design and change. She has held visiting positions in law schools in many parts of the world and is an officer of the Order of Australia and a Chevalier dans l'Ordre National de la Legion d'Honneur of France.



Stijn Smet is a Postdoctoral Fellow with the ARC Laureate Program in Comparative Constitutional Law at Melbourne Law School. His research interests are in comparative constitutional law, human rights, legal theory (primarily on rights) and political theory (primarily on tolerance and respect). Scott Stephenson is a Senior Lecturer at Melbourne Law School, The University of Melbourne. His research focuses on topics of Australian and comparative constitutional law and theory, including federalism, the migration of constitutional ideas, models of rights protection, political backlash against courts, and quasi-constitutional law. After receiving his BA and LLB(Hons) with the University Medal in Law from the Australian National University, he worked at the High Court of Australia, first as the Court's Legal Research Officer and then as Associate (Law Clerk) to Justice Virginia Bell AC. Adrienne Stone is Redmond Barry Distinguished Professor, Director of the Centre for Comparative Constitutional Studies and Kathleen Fitzpatrick Australian Laureate Fellow at Melbourne Law School. She writes on constitutional law and theory with particular attention to freedom of expression and has published widely in international journals on these questions. With Cheryl Saunders, she is editor of the Oxford Handbook on the Australian Constitution and with Frederick Schauer she is editor of the forthcoming Oxford Handbook in Freedom of Speech. She is First Vice President of the International Association of Constitutional Law and is a Fellow of the Academy of Social Sciences in Australia.



Jason N E Varuhas is Associate Professor at Melbourne Law School. His recent books include *Damages and Human Rights* (Hart 2016) (winner of the 2016 SLS Peter Birks Prize for Outstanding Legal Scholarship) and *Administrative Law* (5 ed, OUP 2017) (with Mark Elliott), and two co-edited collections, *Public Law Adjudication in Common Law Systems* (Hart 2016) and *Equitable Compensation and Disgorgement of Profits* (Hart 2017). He has several books forthcoming including *Administrative Law* (Hart 2018) and two co-edited collections, *The Unity of Public Law?* (Hart 2018) and *Remedies for Breach of Privacy* (Hart 2018). His work has been cited by the courts of Australia, New Zealand and the United Kingdom.



Jiunn-rong Yeh is currently the Minister of the Interior (Taiwan). He is the University Chair Professor and Professor of Law at the College of Law, National Taiwan University, Taiwan, where he teaches constitutional law, administrative law and environmental law. He is also the Professorial Fellow at Melbourne Law School, The University of Melbourne. He is known for his policy science approach to various law and policy issues, including constitutional change, environmental policy and regulatory processes. He has been involved in many constitutional, legislative and regulatory issues in Taiwan, including drafting of several major legislative bills, such as the Freedom of Information Act, the Administrative Procedural Act, the Superfund Law and the Greenhouse Gases Control Act. He has received an Award of Excellence in Research from the National Science Council and worked in the Cabinet of Taiwan as a Minister without Portfolio in charge of government reform. In 2005, he was elected Secretary-General of the National Assembly that approved the constitutional revision proposals by Legislative Yuan. Yeh's current publications include "The Constitution of Taiwan: A Contextual Analysis" (Hart Publishing, 2016), *Constitutionalism in Asia: Cases and Materials*, with Kevin YL Tan, Li-ann Thio, and Wen-Chen Chang (Hart Publishing, 2014) and *Asian Courts in Context*, with Wen-Chen Chang (Cambridge University Press, 2014).
