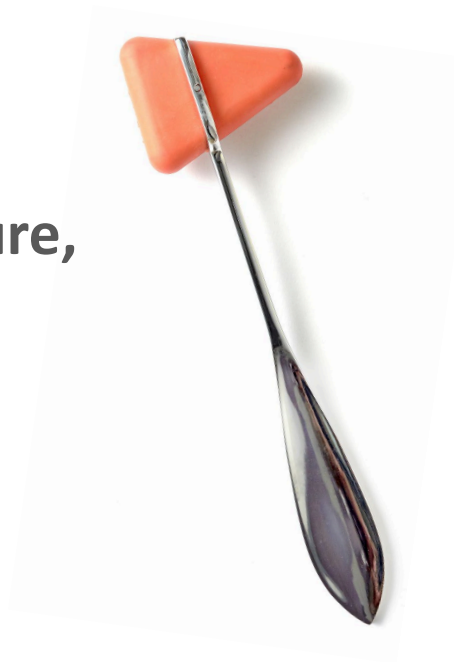

What makes nonprofits competitive?

- Prof. Henry Hansmann pointed to the non distribution constraint in every Nonprofit constitution
- A signal of trust that gave it a competitive edge over other market participants because of reduced transaction costs

For Profit - \$- **contract** – delivery – **monitoring**

vs

Nonprofit - \$ - gift - delivery

Nonprofits have successfully managed unlimited liability for centuries

- Faith based organisations as consensual compacts in law
- Management strategies of unincorporated status and liability
- Exotic legal forms
 - Mutuals – co operatives
 - Company limited by guarantee and shares
 - Community Investment Companies (asset lock)

The first non-profit led philanthropic DAO

Big Green is a USA 501c3 non-profit that believes growing food changes lives. We created a DAO (Decentralized Autonomous Organization) to democratize and decentralize grantmaking for food and gardening organizations in the US.

Kimbal Musk and Big Green

Principle #1: Growing food changes lives. It improves nutrition security, improves mental health, exposes youth and families to nature, and opens our eyes to weather volatility created by climate change.

Principle #2: Putting organizations in decision-making positions disrupts established hierarchies of power in philanthropy.

Principle #3: Streamlining the philanthropic model decreases the level of effort and financial cost for donors and organizations.

Principle #4: Preserving the mission of Big Green DAO and its 501c3 Status requires that grantees will be vetted according to the Big Green Charter.

Principle #5: Any of these principles or governance mechanisms of the DAO can be modified with a $\frac{2}{3}$ majority vote of the DAO Community and $\frac{2}{3}$ majority ratification by the DAO Committee.



How to participate in Big Green DAO

|---------------|---|
| Donate | Make a tax deductible donation to the Big Green DAO Treasury ² and receive one DAO governance token |
| Fund | Receive funding from Big Green DAO accompanied by a DAO governance token |
| Govern | Vote on giving preferences and the direct distribution of funds to non-profit organizations. Grantees become decision-makers for future grants. |
| Grow | Engage on- and offline with the Big Green community and propagate gardening culture. |

Tokens for Humanity

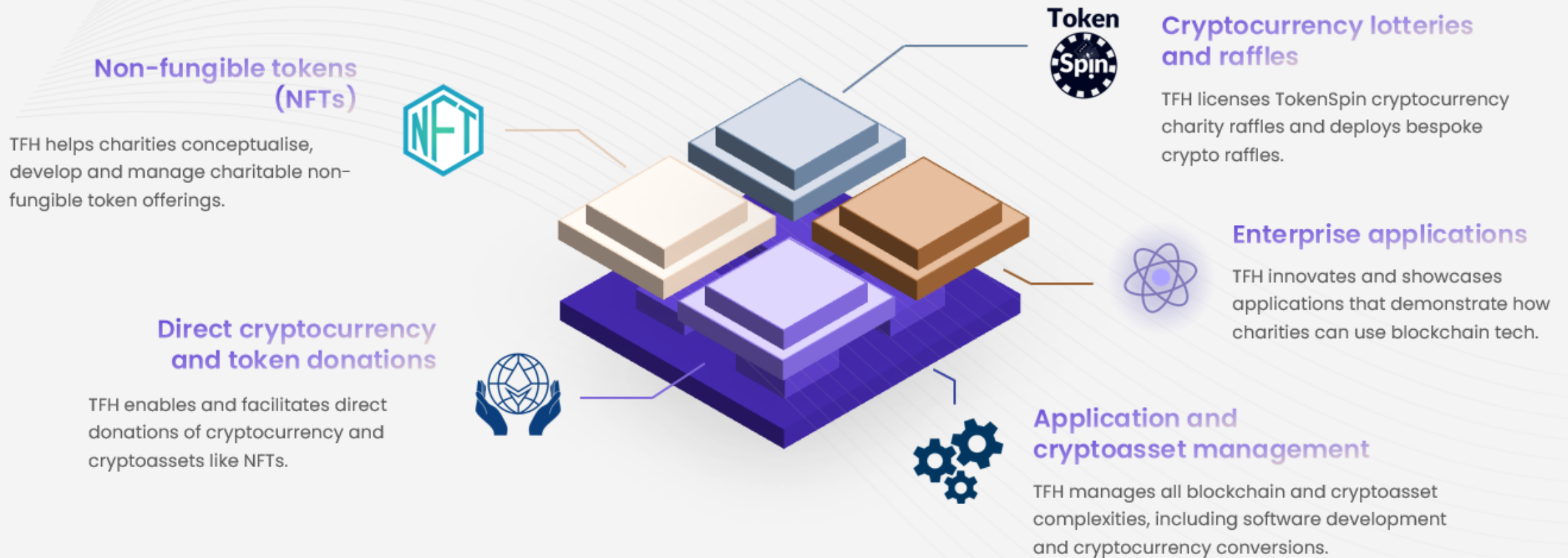


Established in early 2018, Tokens for Humanity (TFH) is an ACNC registered charity specialising in developing deep-technology applications for charities.

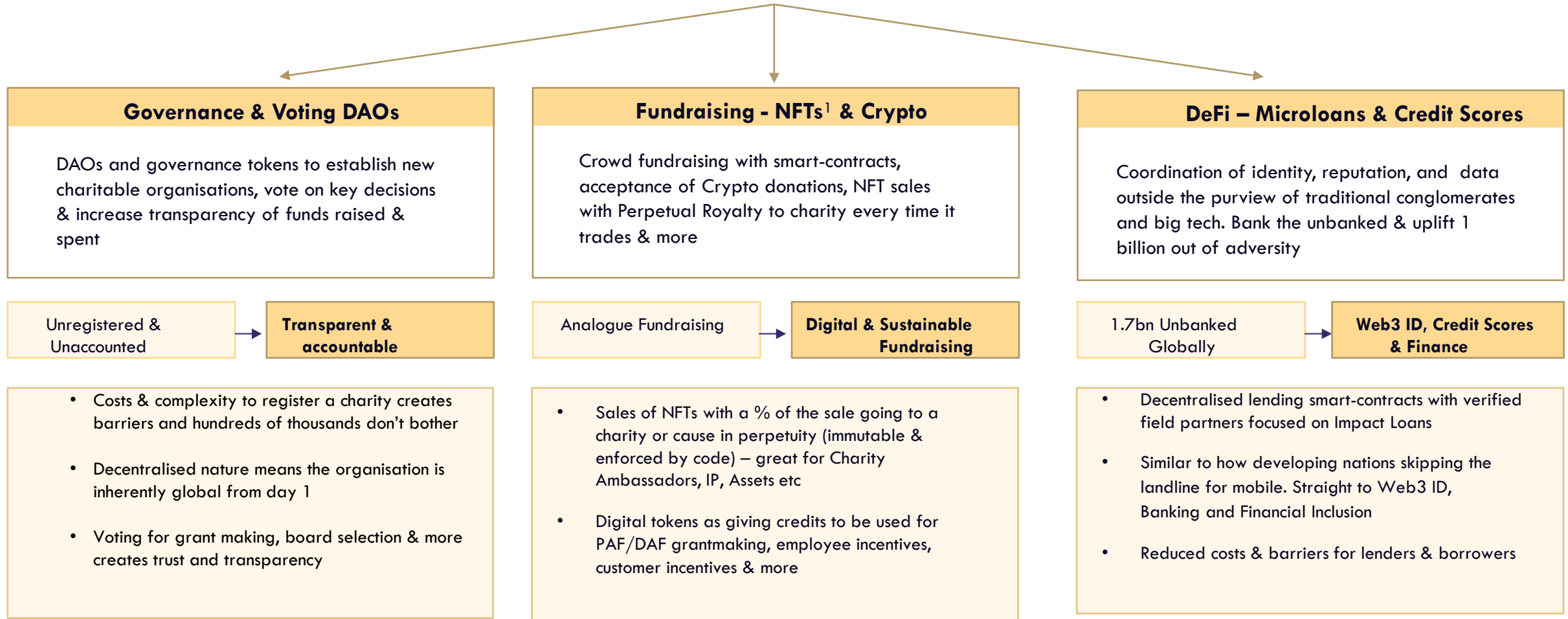
