Dr Andrew Godwin is a Principal Fellow at Melbourne Law School, a member of the Corporate Law and Financial Regulation Research Program at the Melbourne Centre for Commercial Law and Honorary Associate Director (Commercial law) of the Asian Law Centre. Prior to joining Melbourne Law School as a member of the academic staff in 2007, Andrew was in legal practice for over 15 years, 10 of which were spent in Shanghai where he was a partner of an international law firm.

Andrew works and researches in the areas of financial regulation, financial services law, corporate and insolvency law, property law, and the regulation of the legal profession. Andrew has published extensively in both academic and professional journals. He is a co-author of *Sackville & Neave Australian Property Law* and *Ford, Austin and Ramsay Principles of Corporations Law*, and co-editor of *Research Handbook on Asian Financial Law* (Edward Elgar, 2020), *The Cambridge Handbook of Twin Peaks Financial Regulation* (Cambridge University Press, 2021) and *Technology and Corporate Law* (Edward Elgar, 2021).

Andrew served as Special Counsel and Acting General Counsel at the Australian Law Reform Commission from September 2020 to February 2024.
