

#### How did we come to write this book?





# Izzy's case potentially raises all areas of law


- Private law: property law (Isbester as owner of Izzy) and tort law (law of responsibility for wrongdoing) (suing Isbester for harms done by Izzy because she failed to control her dog)
- Criminal law: a criminal offence by Izzy's owner under s 29 of the Domestic Animals Act 1994 where a dog "attacks or bites any person or animal and causes death or a serious injury to the person or animal, the owner of the dog... is guilty of an offence and liable to a penalty not exceeding 40 penalty units."
- Public law: decisions of the Council to euthanize Izzy -> were they properly made?
- Evidence law: did Izzy herself actually attack or bite anyone?




TRIAL OF A SOW AND PIGS AT LAVEGNY.

'Does the Queen own all the swans?' – No, not quite, but the truth is far stranger than that.




'Day of the Tentacle' – should an octopus who took a selfie have copyright in the photo?



# Happy the Elephant

- New York Court of Appeals said Happy the elephant(at Bronx Zoo) could not avail herself of habeas corpus rules (usually applied to humans)
- Happy does not have legal personhood



### Leatherback turtles

- Panama passed a law which allowed sea turtles the legal right to live and have free passage in a healthy environment.
- Any Panamanian citizen can be the voice of the sea turtle and defend them legally
